Policy Statement

Yukon University will appoint individuals as adjunct faculty, research associates, and visiting scholars if it is evident that (1) they will provide knowledge, expertise or skills of value to the institution and (2) the University's reputation will be enhanced through association with the appointee.

The University will consider academic accomplishments, professional experience, or status as traditional knowledge holders when determining eligibility for these appointments.

Vice President, Academic and Student Services

1. Purpose of Policy

Yukon University aspires to be a hub of knowledge production in the North and recognizes that its national and international reputation, academic culture, academic programs, research initiatives, and scholarly activities can be enhanced by associations with distinguished individuals external to the institution. This policy and its accompanying procedures are meant to formalize these external associations by defining the respective roles of adjunct faculty, research associate, and visiting scholars and specifying the range of responsibilities and privileges that may come with these appointments.

3. Scope

This policy applies to all potential appointees to adjunct faculty, research associate, or visiting scholar designations, all current appointees to these designations, and members of the Yukon University community recommending individuals to the designations.

4. Definitions

- Adjunct Faculty: an unpaid, fixed-term academic appointment made to an individual with specific expertise or attainment to contribute to academic programming and/or scholarship activities.
- **Research Associate:** an unpaid, fixed-term appointment made to an individual who has the qualifications and expertise to contribute, as an external researcher, to the work of the University's research centres, laboratories or institutes.
- **Visiting Scholar:** an honorary, unpaid, short-term appointment made to an individual of distinction or special accomplishment who can enhance the University's profile through presentations to the University or the community and/or guest speaking in University courses.
