# 1. Purpose of Policy

The purpose of this policy is to ensure that the Yukon University's response to a death is considerate, respectful, and timely.

## 2. Scope

This policy applies to the Yukon University's response to any Student, Employee, or Community Member who has passed away.

# 3. Definitions

- **Community Member:** an individual with a standing or previous connection to Yukon University ("YukonU" or "University") including but not limited to:
  - o Alumni
  - Past employees
  - Chancellors and members of the Board of Governors
  - Campus Committee members
  - Honorary credential recipients
  - Non-student occupants in Campus Housing
  - Yukon public or elected officials from federal, territorial, municipal, or indigenous governments
  - Yukon University Foundation members
  - University donors
  - Any other community member as deemed appropriate by the President.
- **Employee:** all current faculty, administration, staff, and contract employees of the University.
- **Next of Kin:** a person related by blood, adoption, marriage, common-law marriage, or a person identified by the individual as their next of kin.
- **President's Executive Committee:** the senior executive team of the University as determined by the President.
- **Student:** a student registered at the University.
- **Visitor:** means any individual who is a guest on a campus or off-campus at a university sponsored event who is neither a Student nor Employee.



## 4. Guiding Principles

Yukon University will respond with respect and compassion to any reported death of a Student, Employee, or Community Member.

Yukon University will not comment on the death of a Student, Employee or Visitor until the passing has been confirmed and the Next of Kin have been contacted. The University will not comment on the death of a Community Member unless either the Next of Kin have been contacted or the passing has been publicly reported on.

The University will communicate with the Next of Kin as needed through a dedicated contact person as set out in Policy.

The University's response to a death will be guided by the specific steps set out in Procedures to this Policy.
